**ARTICLES OF INCORPORATION  
OF  
HOI AI HUU HAI QUAN CUU LONG  
A CALIFORNIA NONPROFIT PUBLIC BENEFIT CORPORATION**

**ARTICLE I**

**Name:** The name of this corporation shall be **HOI AI HUU HAI QUAN CUU LONG**.

**ARTICLE II**

**Corporation Status:** This corporation is a **NON PROFIT PUBLIC BENEFIT CORPORATION** and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law exclusively for charitable purposes.

**ARTICLE III**

**Purpose:** The specific purpose for which this corporation is organized to provide financial and emotional support for the former South Vietnamese Navy veterans

**ARTICLE V**

**Tax Exemption Requirements:**

A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3), Internal Revenue Code [26 USCS § 501(c)(3)].

B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code [26 USCS § 501(c)(3)] or by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code [26 USCS § 170 (c)(2)].

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

#### ARTICLE VI

**Distribution Upon Dissolution:** The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

Upon the dissolution of winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) Internal Revenue code [26 USCS § 501(C)(3)].
